Abstract

We study differential wage growth across firms. To this end, we propose a statistical model that extends the workhorse model of wage determination by Abowd, Kramarz, and Margolis (1999) to allow for firm-type-specific wage growth. We estimate the model using linked employer—employee data from Germany for the years 1996 to 2016. We show that wage growth differs across firms and that these differences can at least partially be explained by differential human-capital accumulation. Workers keep the additional accumulated pay when switching firms. This has important considerations for our understanding of the sources of wage inequality. We show that the presence of firm-type-specific wage growth biases the variance and sorting components of the AKM model. The dispersion of worker quality and sorting is less important in explaining wage inequality than previously thought.

Abstract

This paper examines the impact of innovation on migration patterns across skill groups, taking into account labor market, housing market, and amenity responses. Utilizing data from the Chinese Census spanning 2005 to 2015, we find that cities experiencing higher patent growth attract more low-skilled migrants than highskilled migrants, a pattern that contrasts with findings from other developed countries. These cities also exhibit stronger wage growth for both low- and high-skilled workers, but not faster growth in amenities. To interpret these empirical results, we develop and estimate a spatial equilibrium model. Our analysis indicates that low-skilled workers prioritize wages more highly, whereas highskilled workers place greater value on amenities. Furthermore, a higher proportion of skilled workers in a city increases the local supply of amenities. As a result, a positive shock to patent activity draws in more low-skilled than high-skilled workers. This then leads to a reduction in amenities, and thereby further discourages highskilled migration. Counterfactual analysis suggests that technological growth in China has substantially increased wages and welfare for both low-skilled and high-skilled workers. In general, we find that the growth in China in the last decade did not lead to spatial divergence.

The ecosystem is able to use data collected on one product to improve the quality of its other products. The framework is used to evaluate the impact of three data policies on pricing, innovation, and consumer welfare: restricting cross-product data usage within the ecosystem, requiring the ecosystem to share its data with smaller competitors, and establishing a data cooperative among small firms to facilitate data sharing with each other.
