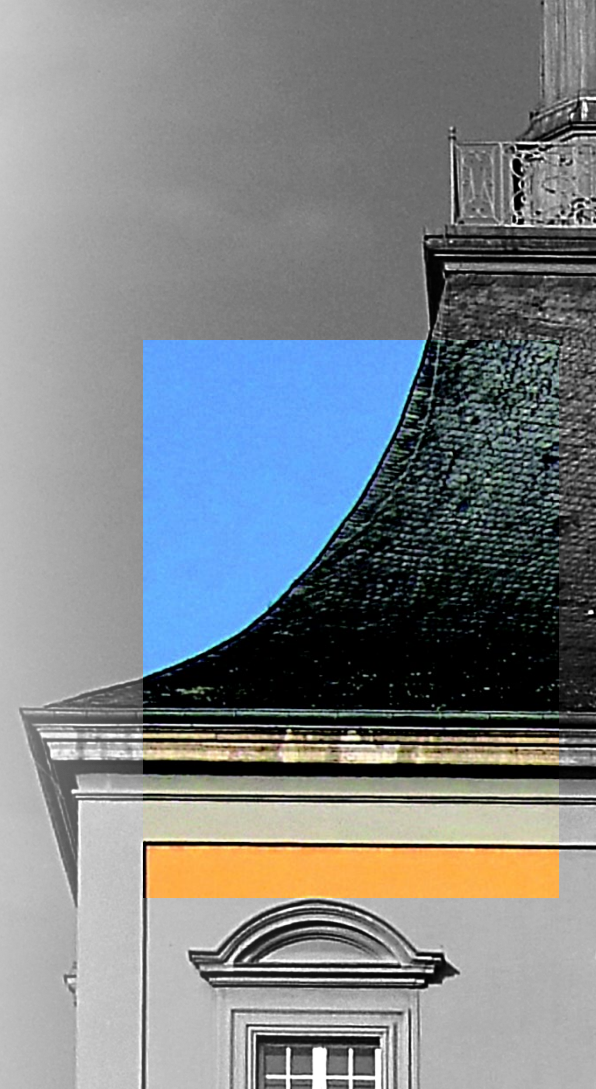

BGSE Alumni (2018-2023):

PHD COURSE PROGRAM

<i>rules of good standing / prerequisites for funding and for proceeding to the doctoral program</i>		
M.Sc. Economics, / Economic Research (two years)	1 st semester	3 Ph.D.-level basic courses in microeconomics, macroeconomics and econometrics, plus mathematics for economists, all 4 courses with a passing grade (i.e. 4.0 or better in every course)
	2 nd semester	3 level-II courses in microeconomics, macroeconomics and econometrics, plus one topics course* or selected M.Sc. course with a passing grade (i.e. 4.0 or better) <i>and</i> an average grade overall 8 courses taken in the first year of least 2.5
	3 rd semester	2-4 topics courses or selected M.Sc. courses (focus on topics courses*) furthermore: BGSE workshop participation
	4 th semester	0-2 topics courses or selected M.Sc. courses (focus on topics courses*) furthermore: BGSE workshop participation, M.Sc. thesis with min. 2.3, find your first supervisor for the dissertation phase
	<i>* Students have to take at least three topics courses.</i>	

PHD COURSE PROGRAM

Doctoral Program (three years)	1 st year	brown bag presentation (1 st semester) find your second supervisor (1 st semester) work on and finish your first paper
	2 nd year	workshop presentation (3 rd semester) work on and finish your second paper
	3 rd year	find your third supervisor (5 th semester) work on and finish your third paper submit your Ph.D. thesis prepare for the job market
<i>The participation in a BGSE workshop is expected during the whole program. Additional offers: soft skill courses, conference participations, research stay abroad</i>		

What is important for you to know if you intend to apply?

Basic courses on master level won't be acknowledged by the BGSE for basic courses on phd level!

What is important for you to know if you intend to apply?

You can apply in 2024 or 2025 or 2026 (or later).

You can already take PhD level basic courses this semester **BUT think about it twice!**

- You will have to **work much harder** (much more work for earning the same grade, **risk of bad grades** in comparison to the regular basic courses).
- You will get a **grant only later** after successfully applying at the BGSE (four years funding instead of five years).
- You can also do the Ph.D. level basic courses later once you have successfully applied and starting the program with a grant and your fellow students.

PHD COURSE PROGRAM

What is important for you to know if you intend to apply?

If you have a **serious** interest in obtaining a doctoral degree in Bonn and if you are willing to take extra risk and much much more work by participating in the PhD level basic courses already this semester, please drop me an email asap (this weekend), shortly explaining your motivation.

BGSE application procedure

- application deadline March 31 (application portal opens in January 2024)
- program starts in October
- one can apply without having a master degree
- online application platform
- necessary documents amongst others:
 - two confidential letters of recommendation, GRE
